Was Held on 7/31/01 at the Central Office

Attended by: Lee M. - Chair, Jim B. - Financial Officer, Jay H. -Dist. 2 Rep., Scott T. - Dist. 4 Rep., Bob G. -Dist. 8

Terry B. -Acting Executive Secretary.

Meeting was brought to order at 6:00 pm. Moment of silence followed by the serenity prayer.

Reviewed; Article VI, Section 8; Structures of the Central Office and Duties and Responsibilities of the Executive Secretary and Staff, as to the motion on the floor in central committee, submitted by John H. to read; Minimum of ten (10) years of sobriety required. A motion was made and seconded to recommend this;

5 yah's, 1 abstained, motion passed

Section 2a: John wanted changed to read; All Central Office Employees shall be elected by a simple majority vote of the Central Committee representatives present and voting at the meeting designated for the election of the staff member. After much discussion a motion was presented by Scott T., seconded by Jim B. to go to the 3rd Legacy Procedure for electing Executive Secretary from the Service Manual. This would require a 2/3-majority vote rather than a simple majority vote. Suggested we eliminate the hat if not obtained and start over. Reminded that this is a paid, long-term job; we want who's best for Alcoholics Anonymous, this helps to invite God into the group conscience; rather than who's better at politicking.

Section 3f; John wanted changed to read; Qualifications for a paid temporary replacement for the Executive Secretary shall be the same as for the Executive Secretary; rather than...same as for the Chairman of the Central Committee. (Article III, Section 1a). Steering committee recommended we revisit it at another time.

Section 6d; John wanted changed to read; Writes checks on all accounts, keeps and maintains proper check book balance. All checks written must have 2 signatures. Authorized signatures shall be the Executive Secretary, Financial Secretary and the Chairman of Central Committee.

Steering Committee/Central Office has already instituted this policy and recommends it.

Discussed that the financial report should be very thorough. Also made a recommendation to have the financial report as presented to central committee, be included in the New Frontiers, so individual members better access it. Also recommended that a notice be put in the Bulletin for groups to check on their contribution and make sure numbers are the same. If not Please call and Question the difference. If this is instituted the cut off dates for the financial reports would change to the 15th – the 15th to co-inside with the New Frontiers print time. (It is currently the 25th-25th)

Discussed moving time and place to better accommodate needed time and concentration.

Discussed an article Sent to Central Office about "Thieves on the job", along with a note about needing to prosecute. Our options were discussed along with the steps we've followed to this point. There was a meeting with the accountant. He advised to question the bank (Corporate Laws) the bank might have some liability. Safe guards were discussed and put into place for financial officer. Statements are in process from the bank, to find out about miss-management and other unaccountable accounts. Will not know how to advise until all the facts are in. Inventory of the literature has been completed on 7/27/01. Now have starting point for all future record of literature. (Holds Ex.Secretary accountable for literature) as advised by accountant. Accountant also talked about putting a lean or judgment against Cindy's future assets. (Wage garnish, ECT.) Again need facts from the bank before recommendations. Also talked about the concepts in these type of matters (warranty concept #5)

Broadway-Bailey Group; District #7,8pm Monday does not meet at St.John Cantinus School; 101 Swineburne (as in schedule). Are they still meeting and where. Haven't been at this church for 3 years.

Central Committee Financial Report Aug. 5, 2001

Wed., 7/18 Scott T., Lee M., Terry B. and myself met with Bill Swierat, of "Gould and Swamson", our (Buffalo central office's) accounting firm. We asked to find the extent of our losses and if and how we can recover them. Bill told us that due to the nature of our transactions, those being mostly cash and undocumented check donations, that it would be impossible to do an exact, or even vague audit of all our financial affairs. The effort would also be expensive. Our literature, however is one area he advised in which we could inventory and keep an accurate account. We've done that inventory as of 7/27. Our accountant suggested that employees of not-for-profit corporations (which we are considered as far as banks are concerned) such as ours, should not be able to drain money market, or c.d. accounts into cash or personal accounts, so the bank, Charter One, may have some responsibility in not being prudent with our accounts. Bill discussed a possibility of recovering our losses with a lien on future earnings and/or property, against our former exec. sec. Scott, Lee, and I agreed to meet with Charter One on Fri., July 20th. Fri., 7/20 The three of us met at cent. ofc. And proceeded to the bank. We spoke with the bank officer most familiar with our accounts and asked how funds from a not-for-profit corp. could have been transferred to a personal account, cashed or otherwise lost. Our conference was held up while the bank found us more chairs and a manager. She, (the manager) told us that the forged loan agreement in the amount of our money market account would not be sufficient to transfer or cash funds. We asked then, how was our account(s) drained? She couldn't tell from the records kept at that branch and suggested searches of our accounts through their main office. Earlier, Lee had inquired about account searches, and was told they are expensive. The manager mentioned \$600 but said the fees would be waived, and the searches would take 2 to 3 weeks. We asked that they initiate the account searches a.s.a.p. While looking at our records, the bank personnel brought to our attention, 5 more accounts, 4 c.d. accounts that were closed around Apr., 2000, and a Fall Convention account that was still active and had our most recent past exec. sec's. name still on it. We discussed some safeguards with the bank, and initiated some at that time. Those were...

- 1) Made it necessary for 2 signatures to be on any document moving funds from any of our accounts, including checking.
- 2) Signers for our accounts will be the exec. sec., cent. ofc. chair, and/or the financial sec. Signatures were submitted to the bank
- 3) Financial secretary will receive bank statements at her/his mailing address and bring them to cent. ofc.
- 4) We were given signature authorization forms to be used when one or more trusted servant rotates out and another takes her/his place.

After leaving the bank, we, Terry, Scott, Lee and I discussed other possible improvements to our money affairs.

1) Starting and maintaining a notebook for financial sec., containing...

A) Duties of the position

B) Signature authorization forms

C) Monthly bank statements

D) Monthly cent. comm. Financial reports

2) Exec. sec. will enter all financial transactions in ledger at central office

3) Financial sec. will meet with exec. sec. at least 2 X ~~weeks~~ ^{Monthly} to go over transaction records and sign any necessary documents

During the week of July 23rd, Charter One called and said that it will cost \$250 to do our account searches. Lee called several steering comm. reps. to find their thoughts on the cost. With pretty much a consensus, Lee told the bank to proceed.

On Aug. 2nd, I called St. Michaels Church for the name and address to mail rent for cent. comm. Meeting, and to find out if we were behind in our rent. The priest that spoke with me said he is aware of our monthly meeting here, unaware of any pending rent and a member of the Kensington group. Terry will send \$35 to the address they gave us on Monday. Thank you
