## Relapse...Slip

What is a relapse? How does it happen? Why does it happen? These questions and many more, plague some of us in AA. Is it because we are alcoholic? Is it necessary for recovery?

Random House dictionary defines relapse as, "as to fall or slip back into former state, into illness after a partial recovery." That is what a relapse is. I speak from experience, having a slip after a decade of sobriety.

It is my belief that a slip or a relapse is caused simply by a failure to follow directions. Yes, the 12 steps of recovery are our simple directions. Once an alcoholic is shown that there is a solution, he or she can no longer use the excuse, "but I'm an alcoholic." The added danger that is paramount lies in the fact that if no major damage occurs during the relapse, the alcoholic may do it again. This is seen in fellowship everyday, "the swinging door alcoholics." Sober a short time; relapse becomes a way of life. Recovery in AA is a Spiritual experience not an intellectual exercise!

I have listened to some AA's who talk about "the spiritual side of the program." The AA program recovery is **A Spiritual Program!** Not partly, but entirely spiritual. Recovery is a celebration of simple choices. We recover one day at a time, sobriety is a never a destination, but always a journey. It is my belief that the farther away from our last drink, the closer we are to the possibility of our next drink. Why? One word; complacency. We assume a smug attitude and take our sobriety for granted. Simply put, we take charge again.

How do we avoid a relapse? Simple, We humbly ask God to remove the obsession to drink. A power greater than ourselves is the answer. Too many of us put all our faith in our sponsors, unfortunately sponsors get drunk. A sponsor is essential to our recovery, in that he or she guides us through the rough spots, and tells us how they did it. Follow the directions to recovery, aka the 12 steps, have a strong faith and trust that God never gives us more than we handle. Regular attendance at meetings, getting

involved in a home group, service work, these things are all essential in our quest for a better life and a better understanding of what Gods will is for us.

Dr. Silkworth, in the Doctors Opinion, writes of relapse: " After they have succumbed to the desire again, as so many do, and the phenomenon of craving develops, they pass through the well known stages of a spree, emerging ever remorseful, with a firm resolution not to drink again. This is repeated over and over, unless this person can experience an entire physic change there is little hope of his recovery."

The first drink gets us drunk, that seemingly innocent drink starts the phenomenon of craving. We are no longer in control.

Recovery is not an easy process, but, armed with the belief and trust of a Power Greater than ourselves, the 12 steps of Alcoholics Anonymous, a home group and a sponsor, we can recover.

"What we really have is a daily reprieve contingent on the maintenance of our spiritual condition." P. 85

I know that Central Committee and the WNY GSA meetings are not for everybody but before you condemn them why not show up and find out for yourself what is going on and how you can give back to God for the gift of Sobriety that he gave you. Unless you don't mind having 10% of the people make up your mind for you.

**My memories of some old timers**

Jerry M was 11 years sober at the time of his death last year. He died of cancer. Several times at discussion tables I heard Jerry state how precious serenity was to him and how any worldly concerns were not important enough to disrupt his serenity. Thank you Jerry. May God rest your spirit in peace.

Joe L was a member of many years sobriety of the UMDG. One year he coordinated the program for the annual men's spiritual weekend. Good job Joe. Joe died a few years back. One of the humorous stories that I recall Joe sharing was about a time he lost his temper while talking with his son. He went to take a swing at him, missed, fell over a chair and tumbled to the floor. Joe had a smile on his face as he was sharing that story. Thanks Joe for showing us how it is OK to be human and to own up to our human frailties, no matter how long we've been sober. Joe passed on but memories of him are still with us.

Bud M and his charming Alanon wife Shirley M were near and dear friends of mine going way back to our drinking days. Bud and I hoisted quite a few together many years ago. Bud died about 3 years ago and Shirley passed on a year or so after. At the time of his death Bud was sober over 25 years. About thirty or so years ago my then

wife (she is now deceased) visited Bud and his charming wife, Shirley, for a Sunday afternoon game of cards. By this time Bud had found his way to AA and got sober. I was still drinking. Shirley was one of those odd class people whom have a characteristic that I do not comprehend – the ability to drink socially. That afternoon, while playing cards, Shirley served pop, coffee, and “ONE” beer to herself and me. Bud exhibited what appeared to me, at the time, a peculiar behavior: he drank pop and refused to come to my aid to serve additional beer to me. A couple of years later I found myself in AA and looked up Bud and had a good “one on one” with him. Some time after that, Shirley and I had a good laugh over the “ONE” beer incident. Thank you Bud and Shirley. May God grant you rest eternal.

When I first realized AA was a spiritual program I wasn't thrilled about the whole idea. All the talk about God irritated me. I had always believed in God but I didn't have a relationship with him. I had blamed God for the terrible things that had happened to me. It was his fault people I loved died, for my parents divorce, the abuse, the accidents, the broken bones, the arrests, the heartaches, anything and everything that had gone wrong.

At the same time I wanted what other members had. That peaceful, calm, and happy look and the gracefulness they have. When I would ask them I would ask how, they'd answer, “Go to a meeting, say a prayer, and don't pick up.” As an alcoholic I decided to do it my way and not pray. However, I did continue to go to meeting after meeting. I came to realize that I was powerless over alcohol and that my life was unmanageable. I was blaming God for things I had done. My drinking was the direct cause of most of my problems. Realizing this I was able to ask God to forgive me.

I began asking him for guidance and strength, I received it, and came to believe. Today I have relationship with the God of my understanding. I don't recall the exact day it

began, it just happened, there wasn't a bright light or a huge sign that went by that said "God is working in your life"; there was just a sense of peacefulness.
