IT'S OURS---WE OWN IT!!!

What is "it"? I am speaking of AAWS (Alcoholics Anonymous World Services, Inc.), an indispensable organization that is a part of and wonderfully supports our General Service Office (GSO). AAWS is our publishing company. Why am I writing this? There are various companies selling copies of the Big Book that do not come from our AAWS. This means that for every book sold through these companies, we're losing, little by little, our own vital financial lifeblood. While we certainly have the right to purchase from whom we choose, I would like to address everyone in an attempt for us all to be fully informed before we make the decision about where we buy our Big Books.

Did you know all the services our GSO performs on behalf of A.A. groups are partly funded by the sale of our literature? GSO does for us what we cannot do for ourselves, in a manner of speaking. Providing a publishing company (AAWS) that publishes all of our conference-approved literature is one of those services we cannot do for ourselves. GSO now has the Big Book of Alcoholics Anonymous translated into 53 languages. Much of our other literature (conference-approved books and pamphlets) is also translated into various languages. Our message is being carried worldwide by GSO through the efforts of our AAWS. This is our publishing company, and we need to continue to support these efforts by purchasing from ourselves. Many of our fellow AA's may not realize how financially important their purchase of AAWS literature is. Their, and our, purchase of our literature through AAWS helps provide for an invaluable archive, providing services for Loners and Internationalists, Public Information, Cooperation with the Professional Community, Correctional Facilities, Treatment Facilities, conducting our A.A. International Convention, general correspondence and service material, International and World Service meetings, General Service Conference, A.A. Regional Forums, Spanish Services and the A.A. Grapevine. This is a lot! It is obvious we need to continue to support ourselves through the purchase of our literature. What happens if we don't? Services will be cut, and where would we start cutting?

Here is what Bill W. had to say about purchasing literature from our own organization: "Some of us have another concern, and this is related to so-called book "profits." The fact that A.A. Headquarters and most of the groups sell books for more than they cost is thought to be spiritually bad. But is this sort of noncommercial book income really a profit after all? In my view, it is not. This net income to the groups and to A.A.'s General Services is actually the sum of a great many contributions which the book buyers make to the general welfare of Alcoholics Anonymous. The certain and continuous solvency of our world services rests squarely upon these contributions. Looked at in this way, our Reserve Fund is seen to be actually the aggregate of many small financial sacrifices made by the book buyers. This fund is not the property of private investors; it is wholly owned by A.A. itself." *Taken from The A.A. Service Manual, Warranty Two, pages 67 & 68.*

While I've talked so much about money, this is about so much more. Here's why: We lost the copy-write to the first edition of the Big Book. That explains why other companies can publish our book, and they can do it cheaper because they do not have all the above services to our fellow AAs attached to the cost. By purchasing a Big Book from

our AAWS, we help ensure that Alcoholics Anonymous and all of the services GSO does for us, will be here for those who follow our footsteps.

Our Regional Trustee, Gary K., has made the following statement on this topic: "I cannot obviously speak for the AAWS Board. Any AA Group, through its (hopefully informed) group conscience, can purchase literature of any kind and character from any source it chooses. As servants we do not govern. Most of us in AA agree that it is BEST that we try to purchase books etc. from AAWS, Inc. for the reasons you stated, but perhaps more importantly for the services the dollars spent on AA literature help to provide, this due to the fact that the Groups do not fully support the services they have requested GSO provide. There are, near as we can tell, approximately 13 outside entities producing our book (albeit the first edition) in various and sundry form (including variants on the original manuscript). Some, like AP, insist they are AA groups, making them virtually immune to any adverse action from AAWS except if currently copyrighted materials are involved. These entities, if they are groups, are working outside the conscience of AA as a whole. Keep in mind that many years ago the groups delegated the literature publishing operations for the Fellowship (first to Works Publishing, now AAWS, Inc). These efforts to publish our basic text, regardless of edition, in my mind are efforts to derail the group conscience for AA as a whole. It is indeed a sad state of affairs when these folks seemingly with impunity, go outside the process to do what they want to do. It's an example of how self-centered we really can be at times. I can only hope that by continuing to educate our Fellowship about how the dollars spent for AAWS literature go towards supporting our service office and structure, and help to provide basic services to the groups and members, a situation which these other entities have less than no interest in. This year, we pared about \$850,000 out of the operating budget to hold down price increases, yet were still unable to forestall the July 1 price increase on all books except the Big Book. I still believe in my heart that if the groups were to demonstrate their responsibilities to AA as a whole by fully supporting GSO through contributions, the price of the literature, over time, would come down to a point hopefully where it was sold at near-cost. At these prices, there is very little economic incentive for outsiders to publish our books. That, in the end, might be the only way to dissuade these folks from continuing in these disruptive endeavors."

Our co-founder, Bill W., and Regional Trustee, Gary K., point out how important it is to support the organization—OUR ORGANIZATION—which has saved our lives. The Board of Trustees of the San Antonio Central Service Office requires that we purchase all our conference-approved literature from AAWS. San Antonio is so privileged to be the host city for the 2010 A.A. International Convention. Let's show the world, when they arrive, Alcoholics Anonymous!

Fables from the Tables

With frightening frequency I hear people telling a newcomer, “who ever got up earliest this morning is the most sober”. Where did this crock of horse-pucky get its’ start. This is another happy PC lie we tell to make someone feel good. Sorry, but it isn’t true at any level. Every member who has invested their time and suffering in early sobriety only to come through on the other side as a useful, somewhat contented and productive former sot should be offended by this I’m OK, Your OK type of fertilizer. Early sobriety stinks and it doesn’t feel good. The best medicine for a suffering newcomer is a dose of your personal experience with that suffering and the way you worked through it. Tell them of your fearful thinking and the sleepless nights. Tell them how your own imaginings that people did or did not like you led to painful resentment that kept you from forming friendships with others. Help them identify with the truth, not some trite PC jargon. Early on, when the tribulations of early sobriety plagued me I was given a course of action to remedy my fears, such as, shake everybody’s hand at every meeting you go to; When the group goes for coffee after the meeting – go; Stop hiding behind your fears, meet them head on or stop whining about them; Get a home group and get involved; Get a sponsor. Do something!!! It is troubling that we have diluted AA down to a handful of pithy somewhat cutesy and untrue sayings that have been raised to a level of common speak. Our message has more depth than that.

Joe did this or that and I don't approve.

They expect me to do something besides suck coffee, spread manure and take up space. They challenge my delusional thinking.

I don't like Joe so I am going assassinate his character. I am not a gossip. I am a paragon of virtue and a beacon of hope.

WHAT GOES AROUND COMES AROUND

Editor's note: this article first appeared in High and Dry, newsletter of Seattle Intergroup, in January 2001.

What goes around comes around.

That phrase usually has a negative flavor, but not for Ralph B. of White Center. Ralph, 44 years sober last Sept. 1, got that way because his employer fired him. Here's how it happened, as he related it in a speech this past November at AA's National Archives meeting here:

"I enrolled at the University of Washington in the spring of 1956...when I picked up another drunk driving arrest. I knew I was going to have to go back to jail. I dropped out of school and went to work for a wonderful man-a man who changed the course of my life. His name was Moe Dinner.

"AA sent a man known to many of you, Eric B., to address a group of businessmen, and Mr. Dinner was in attendance. Eric shared his story about what it was like, what happened, and what it was like now. Moe Dinner was so impressed with his sincerity that he went back to his place of business looking for an alcoholic to help. And when he found one, he fired me and sent me to Alcoholics Anonymous.

"...In those days, the age span of members was between 40 and 60. If you were under 40, you hadn't suffered enough, and if you were over 60, it was too late. Eric didn't think about my age. He just took me in hand and led me into the program."

That was in 1956. Just the other night, 44 years later, Ralph was the featured speaker at Moe's birthday dinner, helping to honor an old friend who turned his life around. Incidentally, he is also now working as a consultant for the printing company from which Dinner fired him way back then.

When he quit the University of Washington that year, he never went back until, after years of sobriety, he was invited to teach in UW's master's program. He has also taught at Pacific Lutheran University and other schools. What goes around comes around.

Ralph came into AA at the tender age of 24, but he had already done his share of hard living. Drinking heavily, he joined the navy and was sent to a duty station in Guam, where he got into enough trouble to be court-martialed and sentenced to hard labor in the Marine brig there. "I was gone for two years. By the time I got back to Seattle, I was a full fledged, card-carrying, raging alcoholic."

Released and sent home, he married his childhood sweetheart, Dawn, and continued his heavy drinking. Ralph says she knew he had a drinking problem, but married him anyway. As his drinking accelerated, she began thinking of divorce until he was fired into sobriety. They have now been married 45 years and have three grown children.

Being forced to go into recovery taught Ralph a lesson he has never forgotten: any method that gets the alcoholic into this program to find sobriety is worthwhile. He is a wholehearted supporter of court-required attendance at meetings, for example. "Arm-twisting is a good alternative to coming in voluntarily," he believes.

Ralph has been a member of the Empire Way group for all his years of sobriety, and currently is leading an effort to strengthen sponsorship. "We've become less assertive in sponsorship over the years, and now we're trying to change that. We are assigning old-timer's to work with new arrivals-take them through the Big Book and explain AA to them in a period of one-on-one meetings, get them sponsors and stop the revolving door."

These initial contact men are not intended to be sponsors, but mentors to the new members. Fifteen mentors have signed up so far. "They tell the newcomers about the importance of reading the Big Book, getting a sponsor, the seventh tradition. Among other things, we're getting much better financial participation now," he said.

The future looks bright for Alcoholics Anonymous, Ralph believes, because so many "beautiful young people are coming into the program. When I came in, a young person like me-I was 24-was a rarity. Now we have many enthusiastic, articulate, exceptionally well-read young people, and they're full of love. People are so much brighter today. They can see the path of destruction, the devastation of alcohol, long before we did. Part of that public awareness is the availability of treatment. It's just wonderful. Another reason is that it is now much more acceptable to be a sober alcoholic."

Ralph takes a middle-of-the-road position on the touchy subject of dual abusers, many of whom are now coming into the fellowship. "I would prefer that we focus on alcoholism, but the longer I stay sober, I try to convince myself never to judge another person, their story or their approach to sobriety. I just want to love them and accept them and help them with their alcoholism."

Ralph has a long track record of service. He was one of the faithful who made the long trek to the state penitentiary at Walla Walla in the program's early days, and to McNeil Island prison. "It's time to bring back that more aggressive approach," he says. In 1967-68, he was a national delegate, the highlight of which was spending a week with AA's co-founder, Bill W., and his wife Lois. "Bill was the most human, wonderful person you could ever imagine. I got him to autograph my Big Book, and when he handed it back to me, he said 'You will never be the same, my son.' He laughed at his little play on words, but he was right."

Ralph is a popular speaker at AA events. Angus L., former Intergroup office manager, made a copy of Ralph's speech to the archivists available for this article. Here are some of the highlights: "On April 19, 1941, the first meeting of the Seattle Group was held at the New Washington Hotel [now the Josephinum]...Three members were present, Carl S., Dave Williams and Bob E...The price of the hotel room was \$4.50, but the group got a discount and paid only \$3. The group didn't meet again until the next month. Compare that with the situation today, with hundreds of meetings a week in the greater Seattle area, some on a daily basis. "

That November of 1941, the tiny core group paid a visit to Charlie Shaedel, who was operating Shaedel (now Schick Shaedel) Hospital for alcoholics. "This hospital has done a tremendous job over the years...They went there to try to get Charlie's failures. Charlie thought it was a great idea..."

Changing to another subject, Ralph said, "I think we should always be grateful for that article by Jack Alexander in the Saturday Evening Post [published in 1941]. It helped spread the word across the nation and gave the answer to hundreds of drunks searching for a solution..."

As he concluded, Ralph praised the assembled archivists for their devotion to preserving the fellowship's history. "Thank you for preserving that past. It has been an honor to be here tonight."

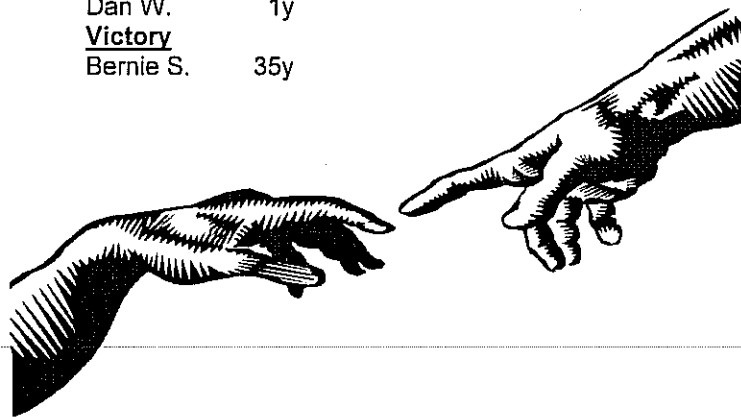


